Notes:

1. For "Type of undertaking," select the category from the major groups of the Japan Standard Industrial Classification.
2. For "Name of the new chemical substance," fill in the name pursuant to the method established by the International Union of Pure and Applied Chemistry (IUPAC Nomenclature).
3. If the new chemical substance has specific properties, such as sublimation, deliquescence or volatility, indicate that in "Others" in "Physicochemical properties of the new chemical substance."
4. Entry must be made in "Requested confirmation period" only when submitting the application pursuant to the provision of Article 34-10 of the Ordinance on Industrial Safety and Health, and such entry is not required for applications pursuant to other provisions.

When requesting confirmation for the amount of manufacture or import for one year, fill in the period in the section "First year." When requesting confirmation for the amount of manufacture or import for two consecutive years, fill in the period in "First year" and "Second year" respectively.

5. For "Amount of manufacture or import," if the application is submitted pursuant to the provisions of Article 34-5 and 34-8 of the Ordinance on Industrial Safety and Health, fill in the planned annual amount of manufacture or import for the first three years after the start of manufacture or import of the new chemical substance (when intending to both produce and import such substance, fill in the total amount). If the application is submitted pursuant to the provision of Article 34-10 of said Ordinance, fill in the planned amount for the period for which confirmation is requested (when requesting confirmation for the amount of manufacture or import for two consecutive years, fill in the amount for the first and second years, respectively).
6. If the new chemical substance is an intermediate product, indicate that in "Usage purpose of the new chemical substance," and fill in the name and usage purpose of the end product in the same section.
7. If the application is submitted pursuant to the provision of Article 34-8 of the Ordinance on Industrial Safety and Health, and if you have made a request concerning the publication of the name of the new chemical substance because of patent application or other reasons, indicate that in "Reference."

If a patent application has been filed for the new chemical substance and a decision of refusal was made for the application or the application was published in the Official Gazette of the Japan Patent Office (JPO) or JPO's Patent Gazette in accordance with the provision of paragraph (3), Article 66 of the Patent Act, notify promptly the Minister of Health, Labour and Welfare of that action.

8. As regards the new chemical substance that had received confirmation prescribed in the provision of Article 34-10 of the Ordinance on Industrial Safety and Health, if the application is submitted pursuant to the provision of said Article in order to continuously receive the confirmation prescribed in the provision of said Article for the relevant new chemical substance after the expiration of the available days of said confirmation, fill in only the chemical formula of the new chemical substance in "Structural formula or rational formula of the new chemical substance."

In such case, no entry is required in "Physicochemical properties of the new chemical substance;" only fill in the confirmation notification number provided when previous confirmation pursuant to the provision of said Article was received in "Reference."

9. When Item 8 above applies and if the application is to be submitted for two or more new chemical substances, use this form only for new chemical substance (1). For the other new chemical substance(s), attach document(s) in which entries are made in "Number of workers engaged in manufacture or handling of the new chemical substance," "Name of the new chemical substance," "Structural formula or rational formula of the new chemical substance," "Requested confirmation period," "Amount of manufacture or import," Usage purpose of the new chemical substance," "In the case of import, the country or region where the relevant new chemical substance is manufactured" and "Reference."
