- Special programmes to control hazardous occupations, child labor, infectious diseases and drug use







### The scope and coverage of DOSH

- Every enterprise or establishment of industries such as Commerce, crafts ,Land or water transportation, whether public, semi-public or privates, agriculture, services, mining, constructions..etc
- Inapplicable: judiciary, public services, domestics or household servants and personnel serving in the air and maritime transportation who are governed by a special regulation (aticle) of Labour Law)

-From 2008 to Q2/2020, There were 213,623 occupational accidents and injuries reported from enterprises: 233,354 cases (Females: 172,728) were reported as workplace accidents and total death 1324 (Females: 440).






#### 2. Labour Inspection System

- Labour inspection is reformed to joint labour inspection in 2016 which is composed of 8 departments of ministry of labour and Vocational Training
- Labour Inspection department, OSH department, child labour department, NSSF, Labour dispute department, Apprenticeship Department, committee for strike and demonstration resolution, and Employment and Manpower Department

#### 2. Labour Inspection System (Cont.)

#### > Three types of inspections are prepared and conducted:

- 1. Regular inspections: Inspections based on the schedule for labour and OSH conditions at workplace.
- 2. Special inspections: Follow-up inspections based on recommendations to the workplace after regular inspections.
- 3. Compliant to court: do not pay the set amount of the special inspection fine on time.

#### > Scope of sectoral coverage

-The labour inspectors cover all occupations in enterprises and companies in the private sector under the scope of the Labour Law of Cambodia, Chapter 1, Article 1.

#### > Application of penal provisions

-Article 375 of Labour Law, fine equivalent of 30 to 120 days' wages or suspension of work



#### 3. Workers' accident compensation insurance

The Law on Social Security Schemes extends the National Social Security Fund (NSSF) to provide a financial security net for civil servants and those in the private and informal sectors. There are 11 chapters with 107 articles. The law passed the Council of Ministers on 02nd August 2019. The law was discussed and approved by the national assembly on 08th October 2019, and was promulgated on 02nd November 2019. The law on Social Security Scheme for persons defined by the Provisions of the Labour Law, was promulgated on 25th September 2002 by the Royal Order No. NS/RKM/0902/018. Additionally, the law covers only workers in private sector.






## Safety day 28.10.2021

# 5. Occupational Safety and Health Management System (OSHMS) and Risk Assessment

OSH management systems are introduced by individual enterprises. The government has been promoting the basic of OSH management systems based on the Plan -Do-Check-Act (PDCA) cycles by means of training and programmes. The government encourages all workplaces, including small and medium-sized enterprises (SMEs) and informal economy workplaces to develop PDCA cycles adjusted to their own working conditions. Moreover, training such as Work Improvements in Small Enterprises (WISE), Work Improvement in Neighbourhood Development (WIND), Work Improvement for Neighbourhood Development and Youth (WINDY), and Work Improvement in Small Construction Sites (WISCON) are provided by the government as useful measures to promote continual improvement and develop basic OSH management systems.

#### 9. New Infectious Diseases (COVID-19) related measures

#### OSH Response During Covid-19 Pandemic

#### A. Training

- MoLVT issued the announcement on prevention and control of Covid-19 at the workplaces for enterprise owners, workers, oversea workers and vocational institutions. (570 Factory/ 102710 workers (F: 81877)

  females).

#### **B.** Quarantine

MoLVT cooperated with MOH prepared 3 quarantine centers and health check up 10 centers for workers who went to their homeland during khmer new year day (Total: 5045 workers) for prevent and control Covid-19.

#### C. Covid-19 Vaccine:

In order to increase immunity in community MoLVT collaboration with MOH, WHO, MoLVT jointed the campaign of Covid-19 vaccination to workers totally: 590,000 peoples (Workers: 130,000 and under umbrella of Arm force 460,000 people).





#### V.Challenges

- ▶ No safety act
- OSH Management system is under development
- ▶ The number of OSH inspectors is limited
- Inspection System is under development without national training and accreditation
- Concern of mine and construction safety
- ▶ No occupational nurses and doctors
- ▶ No OSH training center
- ▶ No physical and toxicology labs.
